CERTIFICATION PROCESS

Upon confirming the organization's readiness for the certification process, Strategic Alliance Integration team provides guidance and assistance in preparing for the management system audits. Pre-requisites of ISO certification:

- Choosing the type of ISO certification
- Choosing the Certification body

5 Steps ISO Certification Process:

PRE-ASSESSMENT (OPTIONAL)

Pre-Assessment Audits are optional, informal and/or abbreviated audit to determine the level of system implementation and readiness for certification audit. They are designed to enhance organization's understanding of the appropriate management system standard and of the entire audit process. Pre-Assessment audits are onsite audits that are tailored according to the customer and focus on the specific management system standard being audited.

CERTIFICATION AUDIT

Certification audit is the first step for the organization to undergo the assessment process to determine if the management system complies with the requirements of the standard.

Certification audits are conducted in 2 stages:

Stage 1 Audit: On-site Readiness Review Audit

The objective of the Stage 1 Audit is to determine the organization's readiness for the Stage 2 Audit. Stage 1 Audits generally cover review of the management system documented information, scope of the management system, organization's processes and operations, as well as any applicable statutory and regulatory requirements. In addition, Internal audits and management reviews are also assessed to determine the organization's readiness to move forward to Stage 2 Audit.

Stage 2 Audit: On-site Certification Audit

The objective of the Stage 2 Audit is to evaluate the compliance with the requirements and verification of implementation and effectieveness of the organization's management system(s).

Stage 2 Audit determines the degree of compliance with the standard's requirements and report any non-conformances of potential non-conformances to be corrected before issuance of the certification. On successful completion of Stage 2 Audit, the organization's management system(s)

CERTIFICATION DECISION AND ISSUANCE OF CERTIFICATE

Independent review of audit report is performed as per the requirement of accreditation to ensure that the auditors remain objective and are consistent throughout the audit process.

Upon satisfactory completion of the review certification decision is reached and the Certification Body will issue an accredited certificate.

Issued accredited Certificates are valid for 3 years' subject to yearly surveillance visits.

SURVEILLANCE AUDITS

Surveillance Audits are abbreviated audits conducted at semi-annual or annual intervals (as agreed) to verify continued system compliance, effectiveness, and continual improvement.

Non conduct of Surveillance Audits leads to certificate termination.

RENEWAL OF CERTIFICATE

Renewal Audit are conduted at the end of certification cycle (every 3 years) before the linked certificate expires, to maintain certification continuity.

The aim is to verify compliance with the requirements applicale at the time, and to determine whether certification can be renewed.
